

UP INTERNATIONAL WEEK 2026 ONLINE AND IN-PERSON TEACHING

Universidad del Pacifico (UP) is a private nonprofit university founded in 1962 by a group of Peruvian entrepreneurs supported by the Society of Jesus. Today it has become a university specialized in the areas of economics and business administration. In the past decades Universidad del Pacifico has been ranked as one of the most prestigious higher education institutions in its fields of specialization in Peru and among the leading institutions of its kind in Latin America.

The International Week is an academic event organized by Universidad del Pacifico aimed at complementing its participants' education (undergraduate students and alumni).

INTERNATIONAL LECTURERS WILL BE RESPONSIBLE FOR:

- Preparing and conducting a 16-hour seminar in English or Spanish from Monday to Friday in the schedule arranged by Universidad del Pacífico.
- Evaluating the students enrolled in the seminar (E.g., Exams, group projects, casestudy).

PAYMENT:

The teaching rate per hour of seminar given will be US\$120.00. From this amount, UP will deduct the corresponding non-resident withholding tax

The taxes to be applied could be 10% if Peru and the country of residence of the LOCATOR have signed an agreement to avoid double taxation and the LOCATOR presents a valid Certificate of Residence, or 24% if such agreement has not been signed.

US\$ 1920.00 before withholding taxes

Payments will be made by international wire transfer to THE LOCATOR 's bank account. It should be noted that the payment will be made within a maximum period of seven (7) working days from the seminar.

STUDENTS PROFILE:

Law School, Business School, School of Economics and Finance, and School of Engineering undergraduate students and alumni can participate in the seminars. We expect to have a minimum of 10 and a maximum of 35 students enrolled per seminar (Average Age: 19-23).

ONLINE AND IN-PERSON MODE:

For 2026, UP International Week will be conducted in a online and in-person mode which means that some seminars will be taught online, and others will be offered in a face-to-face format.

In case your proposal is accepted, and you are willing to visit our campus, Universidad del Pacífico will cover:

- Teaching rate per hour: \$120.00 USD (Minus local taxes)
- · Accommodation with meals and transportation included for the teaching days
- Transport service from the airport to the accommodation and vice versa
- Accommodation in Lima (7 nights)
- Airfare (economy class)
- Travel insurance
- Integration activities

ONLINE PLATFORMS:

Seminars are expected to be given synchronously in the schedules arranged by UP through the Microsoft Teams and Blackboard Learn platforms.

REQUIREMENTS:

Please, make sure to attach the following required documents to your application:

- Ph.D. / Doctorate degree (Mandatory)
- Curriculum Vitae indicating teaching experience
- Seminar Proposal (Download the UP Syllabus template)
- English or Spanish language proficiency certificate (For non-native speakers only)

Once you submit your application, UP will forward your portfolio to the academic authorities. We will let you know whether your seminar proposal has been accepted or not by mid-December (If you applied to teach in the first semester) and by early February (if you applied to teach in the second semester).
